

**WORKPLACE ACCESS FOR ARTISTS AND EMPLOYEES  
in the performance spaces of the  
CHIGIANA INTERNATIONAL FESTIVAL & SUMMER ACADEMY 2022**

All persons must access the workplace from the established entry point.

In addition, all persons accessing the spaces must be equipped with a surgical mask, or a mask offering a higher level of protection.

It is mandatory to use the hand sanitizer.

Before accessing the performance spaces or practice spaces, you are required to fill out and sign the **auto-certification form** (similar to the one attached here).

The performance space will be consistently cleaned and sanitized. During the performance and the use of the space by all involved persons, there will be sufficient staff to clean and sanitize all the bathrooms.

## **ARTISTS**

For all artists it is mandatory to wear a surgical mask (or a mask with increased protection) and to consistently sanitize your instrument. Artists may take off their mask only when they have reached their place on the stage during rehearsals or performances.

The artists will be informed of all procedures to follow.

The indiscriminate use of changing rooms will be allowed as long as masks are worn. (surgical mask or higher level mask, e.g. FFP2).

## **TECHNICIANS**

It is mandatory for all technicians to wear a surgical mask (or higher level protection), and to consistently sanitize their hands.

**ACCESS TO TEACHING SPACES  
(lessons, workshops, rehearsals) FOR STUDENTS AND INSTRUCTORS  
OF THE CHIGIANA SUMMER ACADEMY 2022**

All persons must access the workplace from the established entry point.

In addition, all persons accessing the spaces must be equipped with a surgical mask, or a mask offering a higher level of protection.

It is mandatory to use the hand sanitizer.

Before accessing the performance spaces or practice spaces, you are required to fill out and sign the **auto-certification form** (similar to the one attached here).

**STUDENTS and INSTRUCTORS**

It is mandatory to wear a surgical mask (or a mask with increased protection) and to consistently sanitize your hands and your instrument. Students must always wear masks in the classroom, they can take off their mask when the teaching activities involve them directly (individual lesson). It is recommended to maintain an interpersonal distance of at least 1 meter.

In the case of teaching activities with **wind instruments** it is recommended to always wear an FFP2 mask.

**TECHNICIANS**

It is mandatory for all technicians to wear a surgical mask (or higher level protection), and to consistently sanitize their hands.
